



The objective of eBRAM's institutional services and ODR platforms are to reduce the overhead in managing cases and the friction caused by traditional administrative procedures. eBRAM is the only ODR Provider listed under the APEC Collaborative Framework for ODR of Cross-Border B2B Disputes from Hong Kong and one of seven qualified institutions (under the "Arrangement Concerning Mutual Assistance in Court-ordered Interim Measures in Aid of Arbitral Proceedings" between Mainland and Hong Kong Courts) eligible to apply to Mainland courts for interim measures. Aside from serving as an arbitration and mediation institution, eBRAM also provides LawTech solutions for legal and dispute resolution practitioners through its Hong Kong Legal Cloud service. eBRAM will also soon launch a deal making platform designed to use LawTech to facilitate cross-border transactions and encourage dispute avoidance.
