Asian-African Legal Consultative Organisation (AALCO) is the only intergovernmental organisation in Asia and Africa and a significant force in international law and international arbitration development since its inception in 1956, as a major outcome of the first Asia and Africa Conference held in Bandung in 1955 (the Bandung Conference). **AALCO has 47 member states** (including China), comprising major countries in Asia and Africa (over 90% of which are active participants of the Belt & Road Initiative), which are home to **2/3 of the world's population with combined GDPs exceeding US\$26 trillion.**

AALCO has placed great emphasis on promoting international arbitration services and developed a robust AALCO Dispute Settlement System in Asia and Africa continents since 1975. With the support of the Central People's Government and the Government of the Hong Kong SAR, AALCO-HKRAC has been functioning as AALCO's sixth regional arbitration centre in the world and the first one in North Asia. AALCO-HKRAC has marked the history of the first arbitration institution with international organisation status operating in Hong Kong.

The AAAF 2023 will attract high-level diplomats and legal officers, in-house counsel, business leaders, and other professionals form legal and related industries from the 47 AALCO member states to be present in Hong Kong and online to attend our Forum. It will be the first time for Hong Kong to host such an international legal event under the auspicious of AALCO and attended by senior delegates with diverse background from major countries in Asia and Africa. Terms of Payment

Phone or unpaid bookings will not be accepted. The sponsorship sum is to be paid by cheque or bank transfer (any charges incurred should not be included in the bank transfer amount) within two weeks upon receipt of invoice. The cheque shall be made payable to **AALCO Hong Kong Regional Arbitration Centre**. The organiser reserves the right to release the booking and without further notice to the company in question, should the full amount of the invoice have not been booked into the organiser's account by the due date. Any objection or complaint in connection with the invoice must be submitted to the organiser in writing within 8 days of the date of the invoice.

Cancellation of Sponsorship

The organiser reserves the right to cancel any agreed sponsorship, if any one of the following occurs: (a) the sponsor fails to comply with the relevant payment obligations; (b) bankruptcy proceedings, out-of-court settlement proceedings or winding up proceedings against the sponsor are being carried out or are imminent; and (c) the sponsorship is not or no longer in keeping with the theme of the Forum. No refund will be given under any circumstances.

Event Cancellation, Force Majeure, Cogent Reasons
